APPLICATION TO ERECT A MEMORIAL

Application is hereby made for permission to erect a memorial and for you to construct a foundation, if necessary, on the area described on the reverse of this application, and to permit the monument dealer who signs this application to furnish the memorial in accordance with the rules and regulations of Holy Sepulchre Cemetery.

The memorial will have a Roman Catholic emblem on it in a prominent position, and the overall appearance must maintain the sacred nature of the Cemetery.

It is understood that all memorial work is subject to all the rules of Holy Sepulchre Cemetery in any way affecting monuments, markers, headstones or any other memorials, their manufacture, location, care, erection, removal or in any other regard, subject to all other rules and regulations of the Cemetery now in force or hereafter adopted.

Should any memorial, in the opinion of Cemetery Management become unsightly, dilapidated or dangerous to visitors, it is understood that the Cemetery shall have the right either to correct the condition or to remove the same at the expense of the lot owner or his or her heirs, after giving due notice in writing to the last known address of the lot owner on file in the Cemetery office.

The undersigned who represents that they are the sole and exclusive owner(s) to the right of burial in the grave or lot described above hereby authorize and request Holy Sepulchre Cemetery to permit the erection of the memorial as described on the reverse side of this application, and the construction of a foundation, if necessary, and does hereby agree to all the terms, conditions and other provisions set forth on both sides of this application.

MONUMENT DEALER AGREEMENT

I certify that I have been authorized by the person making this application to prepare a memorial for the previously described location and that the reverse side of this agreement contains a detailed sketch of this memorial.

I certify that this memorial is made entirely of first-grade material and guaranteed by me to be free from all flaws, defects, and tool marks, and that the workmanship on said memorial will be of the highest standard. Should a defect in material or workmanship become apparent before the lapse of five years from date of setting, the management of HSC shall make such declaration in writing to the monument dealer and the memorial will be replaced without cost to the Cemetery or lot owner.

I hereby agree to abide by the rule and regulations of Holy Sepulchre Cemetery now in force or hereafter adopted, in the erection of the memorial, and further agree that, if in the opinion of the Management of HSC the completed memorial not comply with said rules and regulations, it must be rectified to so comply or be removed from the lot within three days of such request, without cost to the Cemetery or lot owner.

The undersigned further agrees to hold the Cemetery free from all liability whatsoever for damage to the memorial that may result from the installation of said memorial, before, during or after the setting of said memorial. I also agree to pay for any damage to lot, graves, walks, trees, shrubs, memorials, etc. during the transportation and setting of this memorial. Certificates of insurance must be on file at the Cemetery office.

No memorial, once erected, may be removed from the Cemetery without written permission of Holy Sepulchre Management.

Acceptance of this permit by the Cemetery and the payment for foundation charges or other payments do not constitute complete approval of this application.
